# What I Learned at the 2013 FARA Symposium

I would like to share my experience of attending my first FARA symposium. I didn't know what to expect, but let me tell you all that I learned. I know that FARA means False Alarm Reduction Association; however, coming from the telecommunications world (AT&T for 30 years) and not ever having an alarm system of my own, I wasn't familiar with a group that supported alarm companies and agencies. I had a knowledgeable trip. I networked and gained insight on a variety of topics. I will share a few of those.



The FARA website has a lot of useful information www.faraonline.org. The website contains bulletins, favorite resources, monthly newsletters, and over 50 people to help you. You can send a FARA assistance request and they will reach out to members to help you with your request. FARA can offer a chance to build leadership skills by helping on committees and team building.

I briefly talked with Sue Smeltzer with Greenville Police Department, and Dee Dee Smith with City of Raleigh Police Department. They both explained that the ordinances were put in place to make sure alarm companies took care of their problems. The police agencies were more concerned with reducing false alarms, than making money. Both agencies agreed that the first false alarm, a post card would be sent to the residence or business. The second false alarm would get a letter stating that they would have to attend a false alarm class. The third false alarm would get a fine from \$50-\$200. They have been very successful and have reduced false alarms over a 5 year period by 65%. I realized after hearing from other jurisdictions that every police department can charge different amounts and that ordinances can be changed quite often. I shared that RFI Security is a 3rd party monitoring station, and they might talk to us as other companies we monitor not only RFI.

The session on SIAC was full of information www.siacinc.org. It had tips on how to use an alarm. It is basically end user education. The PowerPoint's were very helpful, and the speakers were very knowledgeable. The website can be used to educate our dealers and customers, and you can copy and paste any of the information you might need. Currently the installation tech does all end user training. Usually the end user is in a hurry or is anxious for the tech to leave and might not be as knowledgeable as they can be. I brought back a False Alarm Prevention information sheet. This is an information page for Alarm Users. I feel the information on this sheet can help the dispatchers when they are confronted by an end user that is not fully aware of their system, and also we can send the information to the customer. The session on Fire Codes was very informative. I found out that we cannot place fire systems on test for longer than eight hours unless the request is made in writing.

The public safety symposium had a lot of good information. It gave us insight that the future is the smart phone. It was said that we will reduce false alarms by using our smart phone. Many end users can now view, arm disarm, and verify alarms, with their smart phones. I look forward to learning more on this. Consumers want interactive control systems. IP transmissions take less than a second to send a signal. Over pots lines it is 2 minutes. The majority of false alarms are caused by the entry or exit doors.

I didn't realize that most Supervisories are caused by dust and improper cleaning. A majority of false alarms are cause by remodeling buildings without covering the smoke detectors.

I joined the FARA membership committee and look forward to our next FARA symposium in Maryland 2014; I hope to see you there.

The Program is set for the 2014 Symposium at the Embassy Suites BWI hotel from April 28 to May 1, 2014.







The Board may waive the requirements for candidates specified by a two-thirds vote if no candidates meeting the requirements come forward.

Members who are interested in seeking a position as an officer or member of the Board must submit, to the Executive Director, a request for consideration of candidacy for the particular office they are seeking along with a biographical resume no later than ninety (90) days prior (January 29, 2014) to the commencement date of the annual FARA Membership Meeting. The request for consideration of candidacy shall include a brief statement as to why they want to hold the office they are seeking.

1. If the Executive Director only receives requests for consideration of candidacy from one candidate for each position up for vote, then the Executive Director shall not be required to send absentee ballots to the membership.

2. In that case, the Executive Director shall, at the annual FARA Membership Meeting, declare that the nominee is elected by acclamation, and no vote of the membership will be necessary.

## US law enforcement deaths fall to 50-year low, report finds

The number of law enforcement deaths dropped to its lowest level in 54 years in 2013, according to a report published on Monday.

One hundred and eleven officers died on duty this year, the <u>National Law Enforcement Officers Memorial Fund said</u>. The figure <u>marks a decrease</u> from 120 deaths in 2012 and 169 in 2011, and it is the lowest number of law enforcement fatalities since 1959, when 110 officers died on the job.



The preliminary data shows that traffic accidents were the leading cause of officer death, with 46 killed. The second leading cause of death was firearms, which accounted for 33 officer fatalities.

The National Law Enforcement Officers Memorial Fund, a private non-profit organization that promotes officer safety and remembrance, publishes an annual bulletin that documents the number and type of law enforcement officer deaths. The data includes federal, state, local, municipal, tribal, territorial and university officers.

Texas saw the biggest number of officer fatalities in 2013, NLEOMF said, with 13 officers having died there. In California, 10 officers died on duty, and seven died in both Mississippi and New York.

"We're trying to get it to where officer injuries and deaths are no longer accepted as an unavoidable part of the job," said Craig Floyd, NLEOMF chairman and CEO. He said there had been an increased emphasis on officer safety at a federal level after a spike in officer deaths in 2012 and 2011 – when 120 and 169 officers were killed, respectively.

Changes as simple as asking officers to wear body armor and fasten their seatbelts have made a difference, Floyd said. "More than 30% of the officers killed in the line of duty over the past two years were not wearing their body armor. Forty-two percent of the officers killed in auto crashes the last couple of years were not wearing their seatbelts."

Upwards of 90% of agencies now require their officers to wear bullet resistant vests, an increase from 60% in 2009, Floyd noted, and he pointed to other new policies, including officers being prohibited from engaging in high speed pursuits except in certain situations, as another factor.

In 2013, the third highest cause of officer death was job-related illness, which was responsible for 18 deaths, including 14 officers who died as a result of heart attacks linked to particularly stressful incidents while on duty.

The Department of Justice did not immediately respond to requests for data on the number of people killed by police in 2013.

Between 2003 and 2009, an average of 687 civilians died each year during the process of arrest, according to the <u>Bureau of Justice Statistics</u>. In total, 4,813 people died while being arrested over the seven-year period. . <u>More Info</u>
