FARA Secretary John Moorhouse Resigns

Because he has been reassigned outside of the alarm unit, John Moorhouse of the Alachua County Sheriff's Office in Florida, has resigned as FARA Secretary.

John joined FARA in August of 2000 and was appointed FARA Secretary in April of 2003 and re-elected in 2005.

John joined Alachua County as a Deputy Sheriff in 1987, and has worked in numerous bureaus within the Sheriff's Office, including as Bureau Chief for the Combined Communications Center. He created the False Alarm Reduction Unit in August 2000 to handle the county's alarm ordinance. The City of Gainesville adopted a similar ordinance, and at the request of the City Manager, the Sheriff's Office now administers the City's Ordinance. John began implementing both Ordinances in October 2000.

He has also served on the Board of Directors for the Alarm Association of Florida and was active in the Law Enforcement Security Alliance.

"John has been a dedicated Secretary, who rarely missed a meeting. He has also has been a valuable contributing member of the FARA Communications Committee. He contributed to several documents, especially the Model for Electronic Filing of Alarm System Registrations. FARA owes John a debt of thanks. We will truly miss him, we wish him all the best in his future endeavors and hope for an opportunity to work with him again," says FARA President Norma Beaubien.

Kerri McDonald Appointed as Secretary

During the January 23, 2007 FARA Board Meeting, President Beaubien appointed and the Board approved Kerri McDonald to fill the unexpired term of John Moorhouse as Secretary. Kerri was appointed to the At Large Seat in June of 2006 to fill the unexpired term of Stan Hanson, who resigned the seat in April of 2006 after being elected as 2nd Vice President.

Kerri, who runs the alarm unit for the Riverside Police Department in Riverside California, has served on several FARA committees and currently chairs the Exam Subcommittee of the Training and Certification Committee.

"In the case of a vacancy, resignation or removal of an Officer or Director, the President of the FARA shall designate a person to fill the unexpired portion of the previous Officer or Director's term."

The Board of Directors meets face to face at the annual symposium in the spring and also meets in the fall at a two day midyear meeting. The board also has monthly teleconferences that usually last 1 to 2 hours.

FARA Public Safety TIPS Developed

A subcommittee of FARA's Training and Certification Committee has been working very hard to entirely revamp our Professional Certification Program, including new objectives and exams. The new exam will be given for the first time at the training symposium in Dallas.

In creating the new objectives, the subcommittee members discussed, at length, what attributes and knowledge a person should have to be named a Certified Alarm Manager. Once the objectives were rewritten and exam questions prepared, based on those objectives, it was obvious that not all of the information the subcommittee felt was important was contained within FARA documents. The information is available, and sometimes in oblique ways, from other sources or within FARA's regional training program (which is not something most members have access to). In an effort to ensure that those taking the exam can be as prepared as possible, the subcommittee created what are now being called Public Safety Tips. These tips deal with specific items within the objectives. The tips do not lend themselves to full-blown manuals or guides, but deal with important aspects of alarm management that Certified Alarm Managers must know. All are one-page documents.

SSI Hall Salutes Trio for Giving All

Throughout history, the most remarkable people have left their imprints on humankind by virtue of their actions. These heroic figures are altruistic men and women whose impact supersedes mere words, titles or affiliations. The electronic security industry is fortunate to have such dedicated, selfless individuals toil within its ranks.

This year three of them are being honored for their tireless efforts via induction into the Security Sales & Integration Hall of Fame. They are False Alarm Reduction Association (FARA) President and Director of the Montgomery County (Md.) Department of Police False Alarm Reduction Section Norma Beaubien, System Sensor Director Corporate Relations Charlie Darsch and former Bosch Security Systems National Accounts Sales Manager Harvey Eisenstadt.

They share the common thread of expending boundless energy and devoting countless hours during the course of several decades to a wide variety of key industry organizations, events, issues and causes. The entire industry owes them a sincere debt of gratitude as thousands have reaped the benefits of the hard work, blood and sweat that have earned them a spot in the SSI Hall.

Established in 2004 to represent the ultimate recognition for performance excellence, the SSI Hall of Fame annually enshrines those uncommon people who have etched out an indelible impression within the profession, sustained over the course of an entire career. These rare persons' dedication and accomplishments make them uniquely irreplaceable. They are the innovators whose impact has molded and transformed the industry into the thriving, vibrant business it is today.

Selected by a panel of previous inductees and other industry leaders, Beaubien, Darsch and Eisenstadt join the pantheon of other industry greats forever immortalized in the SSI Hall of Fame, which now totals 37 members. As you will see in the ensuing profiles, this trio's impeccable credentials and valuable contributions are indisputable.

Why She's on the List

- Spent more than 20 years dedicated to creating forums and easing tensions between law enforcement agencies and the alarm industry regarding false alarms
- Co-founder and long-time president of FARA, an organization for facilitating optimal communications among law enforcement, alarm companies and end users to stem false alarms
- Turned FARA into clearinghouse for false alarm manuals, guides, prevention bulletins, brochures,

- In law enforcement capacity, manages program that has reduced false alarm dispatches by almost 62 percent as alarm user base grew 115 percent; her initiatives have saved the department more than \$12.5 million in resources since 1995
- In 2005, helped found, launch and administrate the Police Dispatch Quality (PDQ) Award program, which honors alarm companies for false alarm reduction efforts

Most Memorable Moment

"In FARA's early days, as an exhibitor at IACP's annual convention in Charlotte, we had to stay at an unaffiliated hotel. When we arrived, our vice president picked up her room phone only to send numerous cockroaches scurrying for cover. The rest of us went to the hotel restaurant, which turned out to be a sleazy biker bar. We then noticed the lobby featured an automated condom machine. We tried without luck to find another hotel. So, persevere we did!

"I left my room the next morning and was greeted by a man sitting in the hallway in his underwear smoking a cigarette. Later, while waiting in the lobby for the free shuttle to the convention center, an old man with one eye and a very hunched back came in and announced he was our driver. This trip was a never-ending display of 'Oh, my God!' moments."

How Things Have Changed

- "I believe both law enforcement and the electronic security industry are more willing to engage in discussions, entertain the other's viewpoint and gain a better understanding of each other's positions on alarm management techniques.
- "Law enforcement has been forced to do more with less due to the 9/11 attacks. The Columbine High School massacre required us to look at how we deal with school violence. Meanwhile populations grow but most budgets remain constant or decrease. These trends place pressure on law enforcement.
- "The electronic security industry has blossomed the past 10 years due to advancements in technology. Alarm companies can now offer more than a basic alarm system. These advancements have opened doors, and many are taking advantage of that."

What the Future Holds

"It is my hope law enforcement and the industry will continue to develop strong working relationships that will have a positive impact on alarm management issues. As long as the industry continues to view false alarms as a plague and takes substantive and proactive measures to address them, law enforcement will continue, for the most part, to work cooperatively with it."

Something People Might Not Know

"I race in demolition derbies. There is nothing else in this world like the feeling you get when you can legally drive 'hell bent for leather' ramming your 2,000-pound vehicle into someone else's! Engines racing, the sounds made at impact, the smell of burning oil, the cheering crowds — it is a rush like no other."

Reaction to Being Inducted

"I am truly humbled to be the first public safety professional inducted into the SSI Hall of Fame. It is very rewarding to be respected and honored by an industry I ultimately regulate, and shows I am capable of building bridges and fostering an environment where both sides feel comfortable exchanging ideas."

PDQ Award Honors Brink's Success in Reducing False Alarms

Feb 1, 2007, **IRVING**, **TEXAS** -- Brink's Home Security has been awarded the 2nd Annual Police Dispatch Quality Award (PDQ) for excellence in minimizing false police dispatches in Montgomery County (Md.). The Security Industry Alarm Coalition (SIAC), False Alarm Reduction Association (FARA) and Security Sales & Integration sponsor the award.

In winning the 2007 PDQ honor, Brink's demonstrated its commitment to false alarm reduction through its very low police dispatch rates, says FARA President Norma Beaubien.

Brink's Home Security has a combined residential and commercial police dispatch rate in Montgomery County of .17, which places it in the top 1 percent of lowest dispatch rates for companies with more than 50 customers in the county. The national average for police dispatch rates is nearly 1.0, which means every alarm system has at least one false alarm every year.

"Public safety personnel respond to less than one false alarm for Brink's Home Security customers every five years, which is truly remarkable," Beaubien told *SSI*.

Brink's installs control panels that meet the SIA CP-01 control panel standard, approved by the American National Standards Institute (ANSI), which are proven to reduce false dispatches. Brink's also voluntarily employs the use of enhanced call verification (ECV), which entails an alarm company making two calls in an attempt to verify an alarm signal before requesting a public safety dispatch.

"They are seriously committed to training their service and installation technicians, who, in turn, provide outstanding instruction to each and every customer on the appropriate use and operation of the alarm system, as well as how to avoid false dispatches," Beaubien says.

Dave Simon, senior manager of industry and public relations for Brink's, says the company made a commitment nearly 10 years ago to explore ways to reduce false alarms.

"Our goal was to do that not only as a company, but also by participating in alarm industry associations and by sharing what we've learned," he says. "We changed some processes internally — like ECV and targeted customer training — that clearly demonstrated results. We are extremely pleased to receive the PDQ award because it recognizes our company-wide effort."

As the PDQ winner, Brink's will be formally recognized with a special plaque at *SSI*'s SAMMY Awards gala March 27 at 4:30 p.m. at the Venetian Hotel and Casino in Las Vegas. Their trip to the event will be funded by Honeywell's \$1,000 sponsorship. Also for its winning efforts, Brink's and a local law enforcement representative will receive a hometown ceremony, and the company will share its best practices in an upcoming feature article in *SSI*.

SIAC, FARA and *SSI* launched the PDQ program to stem the false alarm problem by recognizing those installing and monitoring companies that follow established industry practices and partner with law enforcement to achieve the highest quality in police dispatch requests. Pittsburgh-based Vector Security captured the inaugural award in 2006.

The 2007 PDQ Award runner-up, Alarm Detection Systems (ADS) of Aurora, III., also distinguished itself as a leader in false alarm prevention initiatives throughout its company, Beaubien says. ADS employs a full-time false alarm team that tracks alarm usage for all customers and pays onsite visits to "high frequency offenders." The false alarm team manager has the authority to initiate system repairs in the event of equipment-related false alarms.

More details of the PDQ Award program will be featured in the March issue of *SSI* and subsequent features later in the year.

CEU Requirements Must Be Submitted No Later Than MAY 2007!!

In order to retain an active FARA Professional Certification designation, each participant must annually obtain one hundred Continuing Education Units (CEUs). It was announced this past April at our 2006 Symposium in San Francisco that all CEU Credits to be considered <u>must be submitted no later that May 2007.</u> Unless the proper number of units is earned and submitted, certifications will become inactive on that date.

Listed activities have been pre-approved for credit. All Certified Alarm Managers may obtain a copy of Pre-Approved Activities by clicking on the link below. Participants may also submit additional activities for consideration for credit. Please submit your inquiry to the FARA Training and Certification Committee. Committee members also decided that a small sub-committee of members of FARA Certified Alarm Managers should be formed to consider any other activities that may be submitted for credit that is not presently listed on the Pre-Approved Activities list. It was further determined that the most equitable manner for FARA to consider unlisted additional activities as acceptable activities for CEU Credits, is by a peer group of Certified Alarm Managers. If you would like to serve on this special sub-committee, please submit your name in writing to either Stan Hanson, Chair of the Training and Certification Committee, or to Brad Shipp, Executive Director of FARA. You will be notified as soon a sub-committee can be formed. If a consensus on a particular activity still cannot be agreed upon, an appeal could be submitted. A decision by FARA's Board of Directors on any appeal would then be final.

ECV Credited for 30% Reduction in Palm Beach False Alarms

Feb 7, 2007, **FRISCO**, **TEXAS** -- Palm Beach County has shown a significant reduction in false dispatches following the instatement of a Florida law governing burglar alarm response. The law calls for state dispatchers to use Enhanced Call Verification (ECV), the practice of calling two phone numbers before dispatching police to an alarm. When implemented on July 1 of last year, Florida became one of the first states in the country to require such a practice. As a result, Palm Beach County Sheriff's Department reduced its dispatches from 12,712 between October-December 2005 to 8,802 during the same time frame in 2006.

Sheriff's Department officials estimate approximately 80 percent of the improvement can be attributed to ECV, which was passed along with other dispatch reduction methods.

With numbers just beginning to become available from across the state, the Alarm Association of Florida (AAF) claims nearly every county appears to have made positive progress.

The proliferation of cell phones is credited as a major proponent for law enforcement agencies across the county to implement ECV, according to the Security Industry Alarm Coalition (SIAC).

Canadian Security Assn. Members Using Cellular Backup

Feb 1, 2007, MARKHAM, ONTARIO, CANADA -- The Canadian Security Association (CANASA) has announced to its members that several wireless communications systems providers have been contacting installing companies and falsely asserting that all Canadian cellular service providers would begin shutting down analogue telephone networks on May 15.

Along with incorrectly stating the networks would be shuttered permanently by June 15, the providers admonished installers to purchase their products before the sunset deadline.

To combat the disinformation, CANASA released the following information to its members:

- Rogers Wireless, the "A" side carrier, has announced that its analog cellular network is targeted to be shut down May 31. While service may continue in some areas after that date, installers are encouraged to work toward a May 31 sunset.
- Bell Mobility has advised CANASA that it will be continuing the Advanced Mobile Phone Services (AMPS) "at least until Feb. 28, 2008."
- Each of the Cellular Alarm Transmission Product manufacturers have communicated with their customers or will be doing so shortly about the status of their individual products.

CANASA also encouraged its members who have used cellular communications products to commence replacement of devices as soon as possible to ensure continued protection for their customers.

New Austin Rules Fine Homeowners After 3 False Alarms

Jan 10, 2007, AUSTIN, TEXAS -- Austin homeowners will face being hit with harsher fines for false alarms on home security systems, according to a newspaper report. A 2005 state law allowed cities to increase fines for false burglar alarms, and Austin started charging slightly larger fines three months ago, according to the American-Statesman.

The Austin City Council is considering adding the changes to a city ordinance, the newspaper reported. Homeowners used to be charged \$50 for six or more false alarms in a year. They can now be charged \$50 for four or five false alarms in a year, \$75 for six or seven and \$100 for eight or more, the newspaper reported. The fine remains \$100 for three or more false alarms on panic buttons, which signal immediate danger. Austin police responded to 23,800 false alarms in 2006.

Alarm Permits Required in Northern California City

Jan 22, 2007, ELK GROVE, CALIF. -- The city of Elk Grove recently mandated that residents and business owners who have an alarm system must have an alarm permit on file with the police department, according to a newspaper report. The permit is required whether an alarm company monitors the system or not. The police department began tracking and billing for false alarms in December.

Under Elk Grove's alarm ordinance, alarm system owners pay no fee for the first two false or panic alarms in a calendar year, the Sacramento Bee reported. The fee for a false burglary alarm is \$75 for a third incident, \$100 for the fourth, \$200 for the fifth and \$250 for the sixth and any subsequent false alarm. For a false panic alarm, the fee for a third incident is \$150, \$200 for the fourth, \$250 for the fifth and \$300 for the sixth and subsequent false panic alarm. Within 15 days of the installation of an alarm system, businesses and homeowners are required to obtain an alarm permit from the department, the newspaper reported. The one-time fee for a new alarm permit is \$50. Once on file, the permits must be renewed every three years. The renewal is free as long as the application is submitted before the deadline.
