Deep Dive: AT&T's Big Fiber-Optic Bet

AT&T execs are going full court press on fiber-optic cable as the company tries to get customers to give up their copper lines, which cost it \$6 billion a year to maintain. "The beauty of fiber is it's symmetrical," CEO John Stankey told Bloomberg TV's *Chief Future Officer*. "It sends the same amount of data up as it sends down."

- That's why it's buying Lumen Technologies' consumer fiber business, a bolt-on that will help it <u>reach major urban centers</u> like Denver and Las Vegas.
- **Another tool** in the arsenal: a wireless home phone. <u>Enter AT&T</u> Phone-Advanced.
- There's even more upside: Swapping old copper for fiber cuts energy use by 70% and maintenance costs by 35%. Plus, AT&T can cash in by selling the leftover copper. "We've got a lot still underground—and at today's prices, it'll pay off," finance chief Pascal Desroches said.


Al enhances 9-1-1 dispatch efficiency by automating nonemergency call filtering and prioritizing urgent incidents, writes Capt. James C. Lutz of the Hanford Police Department in California. These Al tools analyze real-time call data, caller tone, and background noise to

identify emergencies, streamlining workflows and potentially saving lives through faster response times. However, Lutz writes that law enforcement agencies must ensure that AI doesn't compromise cybersecurity, reinforce bias or erode public trust.

Key Points

- 129 new Kansas laws were enacted in 2025, with most taking effect July 1.
- Key legislation includes the establishment of the Office of Early Childhood, a ban on gender-affirming care for minors, and increased campaign contribution limits.
- Tax laws were modified, including a gradual shift to a flat income tax and exemptions for certain vehicles and properties.
- New laws also address child support at conception, fetal development education, government efficiency, and foreign land ownership near military bases.
